Contributions or gifts to Ohio Concrete are not deductible as charitable contributions for federal income tax purposes. However, dues payments are deductible by members as an ordinary and necessary business expense. In accordance with the 1993 Budget Reconciliation Act, a portion of the membership dues that are paid to a trade association, which lobbied for its members in a specific industry are determined to be nondeductible by its members. Ohio Concrete has calculated this percentage to be 13%. This means that 13% of the membership dues paid by your organization for June 2016 are not deductible for income tax purposes.
