Contributions or gifts to Ohio Concrete are not deductible as charitable contributions for federal income tax purposes. However, dues payments are deductible by members as an ordinary and necessary business expense.

**NOTE:** In accordance with the 1993 Budget Reconciliation Act, a portion of the membership dues that are paid to a trade association which lobbied for its members in a specific industry are determined to be non-deductible by its members. Ohio Concrete has calculated this percentage to be 12%. This means that 12% of the membership dues paid by your organization for June 2020 are not deductible for income tax purposes.

## OHIO CONCRETE PAVING CONTRACTORS/ROAD BUILDERS

**Member Definition:** Ohio Concrete Paving Contractors consist of those that pave: highways, airports, streets, roads, industrial and parking areas. Concrete pavement restoration contractors that restore concrete pavements by: patching, stabilizing, diamond grinding, joint/crack resealing and retrofitting dowel bars and reinforcing. Contractors and pavement specialty contractors that build or repair: cement stabilized bases, shoulders, barriers and bridges may also fall within the Ohio Concrete Paving Contractor membership category.

**Dues:** Dues (called assessments) are based on a paving contractor's work volume. It is a reflection the promotion effort that created the opportunity for the work, as well as the technical service that may be required on the project.

### Local Rate:

Local Affiliation (Ohio Chapter Dues):	\$ 500 Annually
Local Assessment (OH):	\$ 1.85 per \$ 1,000

### National Rate:

National Affiliation (Dues):	\$ 0.03 per SY
National Assessment:	\$ 0.55 per \$ 1,000

**Assessable work:** The work that is assessable in local areas as defined by the local affiliated chapter, Ohio Concrete, includes federal, state and local agency project bid items for the following types of work:

- Highway Concrete Paving - Full and Partial-Depth Patching
- Airport Concrete Paving - Diamond Grinding and Grooving
- Street/Road Concrete Paving - Joint and Crack Sawing & Sealing
- Industrial Concrete Paving - Retrofitting Dowel Bars and Tiebars
- Pervious Concrete Paving - Slab Stabilization/Jacking
- Pre-cast Concrete Pavement - Concrete & RCC Shoulders
- Roller-Compacted Pavement - Cement-Stabilized Subbases

### Special Notes:

1. Ohio Concrete is a state affiliate of the American Concrete Paving Association (ACPA). All paving contractors that join Ohio Concrete automatically become members of ACPA, regardless of size or volume of work.
2. All paving contractors who want to become a member of ACPA National, must join through an affiliated chapter or state association (such as Ohio Concrete) unless one does not exist in their territory in which case they may join ACPA National directly.
3. As a fundamental agreement of membership, all paving contractors are obligated to pay local and national assessment dues to any affiliated chapter/state associations in which they perform work and to pay ACPA national assessment dues in areas that are unaffiliated. See Local and National dues rates above.
4. The assessment rates, collection timing and other requirements of each affiliated chapter/state associations apply to the work within its territories performed by any paving contractor member, regardless of their designated "home" chapter/state association.
5. Assessment rates, assessable items and other requirements may vary by affiliated chapter/state association and apply to the work within its territories performed by any paving contractor member. See Assessable work above.
